



JOBS GAINS AND RISING HOME VALUES HELP AMERICANS WITH MORTGAGE PAYMENTS

A resurgent housing market, rising home values and steady job gains are helping more U.S. homeowners stay on top of their mortgage payments. The sharp annual decline in the mortgage delinquency rate represents the biggest quarterly drop on record for TransUnion, whose data go back to 1992.
