In these circumstances, the procedures may state that the services and goods that are to become acquired are those that are most wanting the academic community. In other cases, the supply list may state that the suppliers of the goods and services being bought are those that are associated with the best value meant for the College or university; however , additionally, it is not uncommon intended for the supply list to provide a few exceptions to this basic rule.
